# "METRO CART DASH" CONTEST RULES

# 1. CONTEST PERIOD:

The "Metro Cart Dash" (the "Contest") begins on October 3, 2024, at 12:00:01 a.m. Eastern Time ("ET") and ends on October 15, 2024, at 11:59:59 p.m. ET (the "Contest Period").

# 2. ELIGIBILITY:

(the "Sponsor"), its associated and affiliated entities, advertising/promotion agencies and any other individual(s), entity or entities involved in the development, production, implementation, administration or fulfillment of the Contest (collectively with the Sponsor, the "Contest Parties"), as well as the immediate family members and any persons domiciled with any of the above (whether related or not). # 3. HOW TO ENTER:

# **ENTRY OPTION 1 – ENTRY WITH PURCHASE AND LIMITS:**

To enter, visit https://www.metro.ca/en/contests/cart-dash (Vanity link: metro.ca/cartdash) and follow the directions which require you to provide the unique identifying code from your store purchase receipt along with your email address as the entry point. By providing the unique identifying code and your email address you acknowledge that you have read and agree to be legally bound by the terms and conditions of these official rules and regulations (the "Rules"). To be eligible, your entry or entries as defined herein must be submitted and received during the Contest Period and be in accordance with the Rules. All eligible entries submitted and received in accordance with Option 1 and these Rules (an "Option 1 Entry" or "Entries") will be eligible. Entries must be postmarked by October 15, 2024 and received by October 28, 2024. Mechanically reproduced Option 2 Entries will not be accepted. Your Option 2 Entry may be rejected if (in the sole and absolute discretion of the Sponsor) the Option 2 Entry is not fully completed with all required information and submitted and received in accordance with these Rules. The Sponsor is not responsible for lost, late, illegible, incomplete, misdirected or postage due mail entries. There is a maximum of five (5) Option 2 Entries per day per entrant as evidenced by postmarks.

# ADDITIONAL CHANCES TO PARTICIPATE - ELECTRONIC COMMUNICATION:

An additional chance to participate in the contest will be granted to customers who subscribe to the Metro Ontario newsletter. For customers who already receive the newsletter, by checking the registration box you will also be granted an additional chance and you will not be doubly subscribed to the newsletter.

Eligible Avion Rewards members in the Elite or Premium tier can receive one (1) additional entry in the Contest. To receive the additional entry, eligible Avion Rewards members need to: (1) log into their account at avionrewards.com; (2) go to the Offers page and click on the Metro Contest tile to obtain a unique promotional code; and (3) enter their code on <a href="https://metro.ca/en/contests/cart-dash">https://metro.ca/en/contests/cart-dash</a> for an additional entry into the contest. Promotional code is not redeemable for cash and has no face or cash value. Offer is valid for the first 100,000 eligible Premium and Elite members who redeem their unique promo code at Metro. Premium Non Rewards Non Transacting (i.e. Personal Investment products, Lines of Credit, Home Equity, Loans) members are not eligible to receive an additional entry/promotional code.

# 4. VERIFICATION:

All Option 1 and Option 2 Entries are subject to verification at any time and for any reason. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor, including, without limitation, government issued photo identification) for: (i) the purposes of verifying an individual's eligibility to participate in this Contest; (ii) the purposes of verifying the eligibility and/or legitimacy of any Option 1 or Option 2 Entry or other information entered (or purportedly entered) for the purposes of this Contest; and/or (iii) any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with these Rules. The winner will have an allotted amount of time determined by Metro in its absolute discretion to fill their grocery cart or carts with items up to a total value of \$3,000 during the Shopping Spree. If the total value in the cart or carts is less than \$3,000 at the end of the allotted time, the winner will receive the balance of the Prize value in Metro branded gift cards rounded up. The winner will be randomly selected from all Option 1 and Option 2 Entries that comply with the Contest Rules. The Prize must be accepted as awarded and is not transferable, assignable, or convertible to cash (except as

If the winner is unable, due to disability or ill health, to participate in the actual filling up of the grocery cart, they may assign, subject to the written consent of the Sponsor, their right to fill the grocery cart to a close friend or family member.

# **6. WINNER SELECTION PROCESS:**

There will be 1 draw date (the "**Draw Date**"), **October 31, 2024**, in Toronto, ON at approximately 9:00 a.m. ET. One (1) entrant will be randomly selected among all eligible Option 1 and Option 2 Entries submitted pursuant to the Rules. The odds of winning the Prize is dependent on the number of eligible Entries submitted and received in accordance with these Rules.

# 7. WINNER NOTIFICATION PROCESS:

The Sponsor or its designated representative will make a minimum of three (3) attempts to contact an eligible winner by mail, email address or telephone within seven (7) business days of the Draw Date. If an eligible winner cannot be contacted within seven (7) business days of the Draw Date, or if there is a return of any notification as undeliverable, then he/she/they may, in the sole and absolute discretion of the Sponsor, be disqualified and, if disqualified, will forfeit all rights to the Prize. The Sponsor reserves the right, in its sole and absolute discretion and time permitting, to randomly select an alternate eligible winner from among the remaining eligible Entries submitted and received in accordance with these Rules (in which case the foregoing provisions of this section shall apply to such newly selected eligible winner).

# 8. WINNER CONFIRMATION PROCESS:
